### Agreement

- 1. This agreement is entered into between the Brazil Federal Public Administration, hereby represented by the Ministry of Transparency, Oversight and Comptroller General ("CGU") through its Minister, and the International Bank for Reconstruction and Development ("IBRD").
- IBRD has developed a software with the purpose of support the implementation of the Internal Audit
  Capability Model (IA-CM), created by the Institute of Internal Auditors (the "Software"). The
  Software does not include the related software Drupal or any other software developed by any third
  party.
- 3. The Software is hereby licensed to CGU without cost under the GNU General Public License, version 3, attached hereto as Annex 1, with the modifications made in this agreement.
- 4. IBRD will not provide support, maintenance, or any other services relating to the Software to CGU.
- 5. This agreement shall commence on the effective date on the face hereof and shall remain in effect as otherwise provided indefinitely.
- 6. In accordance with section 7 of the GNU General Public License and in order to limit the liability of IBRD, the GNU General Public License is amended as follows:
  - a. Any dispute or difference arising out of, or in connection with, the GNU General Public License or the breach thereof shall be arbitrated in accordance with the UNCITRAL Arbitration Rules as at present in force. The arbitration shall take place in New York. Any resulting arbitral decision shall be final and binding on all parties. The GNU General Public License shall be interpreted in accordance with the substantive laws of New York.
  - b. Nothing in the GNU General Public License shall constitute or be considered to be a limitation upon or a waiver of the privileges and immunities of any member of the World Bank Group, which privileges and immunities are specifically reserved.
- 7. CGU shall indemnify, defend and hold harmless IBRD, its officers, directors, employees and agents against all claims, suits, damages and losses arising out of or relating to this agreement or the use of the Software by Brazil Federal Public Administration, any of its agents or representatives.
- 8. In accordance with the Articles of Agreement of IBRD, no actions shall be brought by CGU or persons acting for or deriving claims from CGU against the IBRD relating to this agreement. For the avoidance of doubt, nothing herein shall constitute or be considered to be a limitation upon or a waiver of the privileges and immunities of any member of the World Bank Group, which privileges and immunities are specifically reserved.

# ANNEX 1

# GNU GENERAL PUBLIC LICENSE

### Preamble

The GNU General Public License is a free, copyleft license for software and other kinds of works.

The licenses for most software and other practical works are designed to take away your freedom to share and change the works. By contrast, the GNU General Public License is intended to guarantee your freedom to share and change all versions of a program--to make sure it remains free software for all its users. We, the Free Software Foundation, use the GNU General Public License for most of our software; it applies also to any other work released this way by its authors. When we speak of free software, we are referring to freedom, not price. ## 17. Interpretation of Sections 15 and 16.

If the disclaimer of warranty and limitation of liability provided above cannot be given local legal effect according to their terms, reviewing courts shall apply local law that most closely approximates an absolute waiver of all civil liability in connection with the Program, unless a warranty or assumption of liability accompanies a copy of the Program in return for a fee.
